#### WHAT THE JOB INVOLVES:

Health Services Manager is a management class of positions with several assignment levels. Health Services Managers, under direction, with wide latitude for the exercise of independent judgment and initiative, plan, develop, and administer public health or mental hygiene programs of considerable size and/or complexity. The duties of a Health Services Manager may include administrative supervision of clinical, as well as other professional, clerical, fiscal, analytical, and support staff; and responsibility for contract administration, allocation of funds, monitoring, evaluation, and contract compliance in one or more service areas. All Health Services Managers perform related work.

Within the following agencies, Health Services Managers may also be assigned the following duties and responsibilities:

In the Department of Health and Mental Hygiene, under direction, with wide latitude for the exercise of independent judgment and initiative, Health Services Managers may administer the non-medical aspects of Health District(s); plan, develop, and administer public health programs such as lead poisoning control, disease intervention, personal health services, child and adolescent health, laboratory services, and environmental health; and perform related work.

In the Fire Department, under executive direction and with very wide latitude for the exercise of independent judgment and initiative, Health Services Managers may administer various sections of the Bureau of Health Services including, heading the Counseling Service Unit; conducting candidate medical evaluation, incumbent medical treatment and/or World Trade Center monitoring/treatment; offering psychological assessments, counseling and referral services to Uniformed Fire Members, EMS, Civilian employees and their families; and perform related work.

**In the Department of Education**, under general direction, Health Services Managers may plan, direct, administer and control review and evaluation of student health and wellness programs; maintain administrative supervision of professional staff and support personnel; and perform related work.

**In the Department of Correction**, under general direction, Health Services Managers oversee correctional health care programs, provide oversight, review policy and collaborate with other stakeholders to provide services to the inmate population; and perform related work.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

**Special Working Conditions:** Health Services Managers may be required to work shifts including nights, Saturdays, Sundays, and holidays. Health Services Managers may be on call 24 hours a day, 7 days a week.

## THE SALARY:

Salaries will be consistent with the level of responsibility of the assignment. Salaries for appointments to managerial assignments will be consistent with the Managerial Pay Plan. Salaries for appointments to nonmanagerial assignments will be made in accordance with the collective bargaining pay plan.

#### **HOW TO QUALIFY:**

You are responsible for determining whether or not you meet the education and experience requirements for this examination prior to submitting your application. If you are found "Not Qualified," your application fee will not be refunded <u>and you may not receive a score</u>.

You will **not** receive credit for education which you obtain after January 31, 2020 or experience which you obtain after the end of the Application Period (July 23, 2019).

#### **EDUCATION AND EXPERIENCE REQUIREMENTS:**

A baccalaureate degree from an accredited college or university and five years of full-time satisfactory
experience in a health services setting such as a laboratory, hospital, or other patient care facility, or
in a public health, community health, environmental health, school health, social services program,
or mental hygiene program at least 18 months of which must have been in a managerial or

- administrative capacity requiring independent decision-making concerning program management, planning, evaluation for quality improvement and assurance, allocation of resources, and the scheduling and assignment of work; or
- 2. Education and/or experience equivalent to "1" above. Graduate credits from an accredited college or university in hospital administration, public health, community health, public administration, business administration, management or administration may be substituted for a maximum of two (2) years of the required experience on the basis of 30 semester credits for one (1) year of the required nonmanagerial experience. However, all candidates must have a minimum of a baccalaureate degree and 18 months of managerial or administrative experience as described in "1" above.

Administrative work experience includes the authority to make critical decisions about matters of significance. Experience which primarily consists of clerical office support activities is not qualifying.

The education requirement must be met by January 31, 2020. The experience requirement must be met by the last day of the Application Period (July 23, 2019).

The college or university must be accredited by regional, national, professional, or specialized agencies recognized as accrediting bodies by the U.S. Secretary of Education and by the Council for Higher Education Accreditation (CHEA).

If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. This is required only if you need credit for your foreign education in this examination. For more information see the Foreign Education Evaluation Guide in the Required Information section.

You have until midnight Eastern time on the last day of the Application Period (July 23, 2019) to clearly specify in detail all of your relevant education and experience on your Education and Experience Test and submit it in the Online Application System (OASys). Once you submit your Education and Experience Test in OASys, you will not be permitted to submit new or additional information about your education and/or experience online. information about your education and/or experience online.

You will not receive credit for education which you obtain after January 31, 2020 or experience which you obtain after the end of the Application Period (July, 23, 2019).

#### The Protection Of People With Special Needs Act:

Article 20 of the NYS Executive Law and Article 11 of the NYS Social Services Law require an authorized agency to inquire whether a candidate selected for employment to a position with the potential for regular and substantial contact with individuals receiving services has been found responsible for serious or repeated acts of abuse or neglect through a check of the Vulnerable Persons' Central Register that includes a Staff Exclusion List maintained by the NYS Justice Center for the Protection of People with Special Needs. Candidates who are on the Staff Exclusion List will not be hired or assigned to such a position.

#### **Assignment Of Duties**

Section 424-a of the NYS Social Services Law requires an authorized agency to inquire whether a candidate selected for employment who will have the potential for regular and substantial contact with individuals who are cared for by the agency, is, or has been, the subject of an indicated child abuse and maltreatment report on file with the Statewide Central Register for child abuse and maltreatment. Statewide Central Register checks will be obtained as part of the background screening process for selected candidates where the inquiry of the Vulnerable Persons' Central Register did not uncover disqualifying information. Candidates who have been the subject of an indicated child abuse and maltreatment report may be excluded from employment.

### **Residency Requirement Advisory:**

Under New York City Administrative Code Section 12-120, you might need to be a resident of the City of New York within 90 days of the date you are appointed to this position. Since residency requirements vary by title, appointing agency and length of service, consult the appointing agency's personnel office at the time of the appointment interview to find out if City residency is required.

## **English Requirement:**

You must be able to understand and be understood in English.

## **Proof of Identity:**

Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with the City of New York.

For any account creation issues, you will receive onscreen prompts to contact DCAS. This review may require up to two (2) business days to be reviewed and resolved. Please keep this information and the application period deadline in mind when creating your account.

#### THE TEST:

Your score will be determined by an education and experience test. You will receive a score of 70 points for meeting the education and experience requirements listed on pages 1 and 2. After these requirements are met, you will receive additional credit up to a maximum of 100 points on the following basis:

You will receive a maximum of one year of experience credit for each year you worked. If you have any of the above experience on a part-time basis, it will be credited according to the equivalent percent of full-time experience. You must clearly specify in detail all of your relevant education and experience on your Education and Experience Test and submit it by the end of the Application Period. You will not receive credit for education which you obtain after January 31, 2020 or experience which you obtain after the end of the Application Period (July 23, 2019).

### THE TEST RESULTS:

If you pass the education and experience test, your name will be placed in final score order on an eligible list, you will be given a list number and you will be notified by mail of your test results. The eligible list determines the order by which candidates will be considered for appointment. If you meet all requirements and conditions, you will be considered for appointment if your name is reached on the eligible list. Once a list has been established, it will typically remain active for four years.
