# NOTICE OF EXAMINATION

## WHAT THE JOB INVOLVES:

Graphic Artists under varying degrees of supervision, and with some latitude for independent action and judgment, perform technical and creative work in the design, layout, presentation, and illustration of materials, and interpret informational data in graphic form; use a variety of media and tools, including specialized computer graphics programs and computer-driven tools. There are two Assignment Levels in this class of positions. All Graphic Artists perform related work.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

## THE SALARY:

The current minimum salary is \$49,822 per annum. This rate is subject to change.

## HOW TO QUALIFY:

You are responsible for determining whether or not you meet the education and experience requirements for this examination prior to submitting your application. If you are found "Not Qualified," your application fee will not be refunded and you will not receive a score. You will not receive credit for education which you obtain after June 30, 2024, or experience which you obtain after the end of the Application Period (March 26, 2024).

## EDUCATION AND EXPERIENCE REQUIREMENTS:

1. A baccalaureate degree, with a major in fine or graphic arts, from an accredited college or university **and** one year of full-time paid experience as a commercial or graphic artist; **or**
2. A four-year high school diploma or its educational equivalent plus two years of training in an approved technical school in oils, water colors, painting, design, black and white, layout, computer graphics, and other art media, **and** three years of acceptable full-time paid experience as a commercial or graphic artist, **or**
3. Successful completion of one year of the Civil Service Pathways Fellowship program.

**The education requirement must be met by June 30, 2024. The experience requirement must be met by the last day of the Application Period (March 26, 2024).**

**The Civil Service Pathways Fellowship program requirement must be met by the last day of the Application Period (March 26, 2024).**

The high school diploma or its educational equivalent must be approved by a State's Department of Education or a recognized accrediting organization. The college or university must be accredited by regional, national, professional, or specialized agencies recognized as accrediting bodies by the U.S. Secretary of Education and by the Council for Higher Education Accreditation (CHEA).

If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. This is required only if you need credit for your foreign education in this examination. For more information see the Foreign Education Evaluation Guide in the Required Information section.

During the Education and Experience Exam (EEE), you may answer questions about your experience. If your experience was on a part-time basis working less than 35 hours per week, you will need to convert your part-time experience to full-time experience using the formula below. Once you have determined your full-time experience equivalent, use this amount to answer questions about your experience.

(number of hours worked per week/35) x (number of months worked)

**READ CAREFULLY AND SAVE FOR FUTURE REFERENCE**

For example, if you worked at a job for 21 hours per week for 12 months, you would make the following calculation:  $21/35 \times 12 = 7.2$  months.

**You have until midnight Eastern time on the last day of the Application Period (March 26, 2024) to clearly specify in detail all of your relevant education and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.**

**If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (March 26, 2024), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.**

**You will not receive credit for education which you obtain after June 30, 2024 or experience which you obtain after the end of the Application Period (March 26, 2024).**

**Residency Requirement Advisory:**

Under New York City Administrative Code Section 12-120, you might need to be a resident if the City of New York within 90 days of the date you are appointed to this position. Since residency requirements vary by title, appointing agency and length of service, consult the **appointing agency's personnel office** at the time of the appointment interview to find out if City residency is required.

**English Requirement:**

You must be able to understand and be understood in English.

**Proof of Identity:**

Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with the City of New York.

**HOW TO APPLY:**

If you believe you meet the requirements in the "How to Qualify" section, apply using the Online Application System (OASys) at [www.nyc.gov/examsforjobs](http://www.nyc.gov/examsforjobs). Follow the onscreen application instructions for electronically submitting your application, payment, and completing any required information. A unique and valid email address is required to apply online. Several internet service providers, including but not limited to Google, Yahoo!, AOL, Outlook.com, and Mail.com offer free email addresses. **All new OASys accounts require verification before a candidate can apply to ensure the accuracy of candidate information. Verification is instantaneous for most accounts and you will receive a confirmation email with instructions to activate your account. For any account creation issues, you will receive onscreen prompts to contact DCAS. This review may require up to two (2) business days to be reviewed and resolved. Please keep this information and the application period deadline in mind when creating your account.**

The following methods of payment are acceptable: major credit card, bank card associated with a bank account, or a prepaid debit card with a credit card logo which you may purchase online or at various retail outlets. If you are receiving or participating in certain forms of public assistance/benefits/programs, or are a veteran, you may qualify to have the application fee waived. To schedule a customer service appointment through OASys for an exam-related or eligible list-related inquiry, find **Exam #1889**, click **Apply**, and follow the instructions provided to reserve your appointment location, date, and time.

**REQUIRED INFORMATION:**

- 1. Application for Examination:** Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.
- 2. Education and Experience Exam:** Fill out all the required sections displayed onscreen (if applicable). You will have until midnight Eastern time on the last day of the Application Period (March 26, 2024) to clearly specify in detail all of your relevant education and experience on your Education and Experience Exam and submit it in the Online Application System (OASys).

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (March 26, 2024), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

- 3. Foreign Education Evaluation Guide (Required only if you need credit for your foreign education in this examination):** If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. The services that are approved to make this evaluation are listed on the Foreign Education Evaluation Guide which is located on the DCAS website at <https://www1.nyc.gov/assets/dcas/downloads/pdf/employment/foreigneducation.pdf>. When you contact the evaluation service, ask for a "**document by-document**" (general) evaluation of your foreign education. You must have one of these services submit its evaluation of your foreign education directly to the Department of Citywide Administrative Services no later than eight weeks from the last day of the Application Period (March 26, 2024).

**THE TEST:**

Your score will be determined by an Education and Experience Exam. You will receive a score of 70 points for meeting the education and experience requirements listed above. After these requirements are met, you will receive additional credit up to a maximum of 100 points on the following basis:

**If you have satisfactory full-time experience as a commercial or graphic artist either painting or using industry accepted digital creation tools for the purpose of digital layout, photo editing and/or digital illustration including but not limited to Adobe Photoshop, Illustrator and InDesign; Autodesk software; Adobe Acrobat; Adobe Premier Pro; Final Cut Pro; Power Point; Dream Weaver; Adobe Animate; QuarkXPress and After Effects for:** **You will receive up to:**

At least 1 year but less than 2 years of experience	7.5 points
At least 2 years but less than 3 years of experience	15 points
At least 3 years but less than 4 years of experience	22.5 points
4 years or more of experience	30 points

**If you have satisfactory full-time experience producing projects which require pre-press production for high volume printing; high speed digital presses, large format printing and finishing for:** **You will receive up to:**

1 or more years of experience	10 points

During the Education and Experience Exam (EEE), you may answer questions about your experience. **Education must be obtained by June 30, 2024 and experience and certifications must be obtained by the last day of the Application Period (March 26, 2024).**

#### **THE TEST RESULTS:**

If you pass the Education and Experience Exam, your name will be placed in final score order on an eligible list, you will be given a list number, and you will be notified by email of your test results. The eligible list determines the order by which candidates will be considered for appointment/promotion. If you meet all requirements and conditions, you will be considered for appointment/promotion if your name is reached on the eligible list. Once a list has been established, it will typically remain active for four years. If you believe that your test part was rated incorrectly, you may submit an appeal of your score to DCAS, Committee on Manifest Errors, through the Online Application System (OASys). Your appeal must give specific reasons why your score should be higher. Your appeal may result in a higher or lower rating.

5. Select the reason for your appeal from the Appeal Reason drop-down list (if applicable).
6. Enter the details of your appeal by providing specific reasons why your score should be higher.

#### **ADDITIONAL INFORMATION:**

**Appointment Interview:** Candidates may be required to present a portfolio representing their qualifying work at the time of the appointment interview.

#### **Application Receipt:**

You will be emailed a receipt immediately after you have applied for the examination. If you do not receive this receipt, check "Junk", "Trash", or "Spam" folders for the primary email linked to your Online Application System (OASys) account. If you are unable to locate the email, you can view a summary of the notification email to you on your OASys Dashboard, then Notifications. If you are still unable to find the email, please email DCAS via the Contact feature available in OASys with a description of the issue and include the exam number and your profile number located on your Profile page. While on your Profile page, check that the email addresses you provided are correct and/or updated.

**PENALTY FOR MISREPRESENTATION:**

Any intentional misrepresentation on the application or examination may result in disqualification, even after appointment, and may result in criminal prosecution.
